Notes to proxy

1. If you are voting on behalf of a corporation or another individual you must sign this proxy with signing capacity stated, and you may be required to provide documentation evidencing your power to sign this proxy.

4. If this proxy is not dated, it will be deemed to bear the date on which it is mailed by Management to the holder.
